THE CORPORATION OF THE TOWN OF TECUMSEH

BY-LAW NUMBER 2008-04

Being a By-law to designate community safety zones in the Town of Tecumseh.

WHEREAS Section 214.1 of the *Highway Traffic Act*, R.S.O. 1990, c. H.8, as amended, provides that the Council of a Municipality may by By-law designate a part of a highway under its jurisdiction as a community safety zone if, in the council's opinion, public safety is of special concern on that part of the highway;

AND WHEREAS the Council of The Corporation of the Town of Tecumseh is of the opinion that public safety is of special concern on highways adjacent to schools and public parks;

AND WHEREAS the Council of the Corporation of the Town of Tecumseh enacted Bylaw No. 2005-70 designating community safety zones in the Town of Tecumseh, on the 11th day of October, 2005, as amended by By-law No. 2006-62 and 2007-96;

NOW THEREFORE the Council of The Corporation of the Town of Tecumseh enacts as follows:

- 1. **That** the locations in the Municipality designated in Column 1 of Schedule "A" to this By-law for the time shown in Column 2 of said Schedule, are hereby designated as Community Safety Zones.
- 2. **That** this By-law becomes effective upon the final passing thereof and upon the erection of the signs prescribed in accordance with the said Act.
- 3. **That** By-law No. 2001-49, as amended and By-law No. 2005-70, as amended and any by-law inconsistent with this by-law is hereby repealed.

READ a first, second and third time and finally passed this 12th day of February, 2008.

That part of Lacasse Blvd beginning at the northerly limits of the intersection of Lacasse Blvd. and Dube Drive and extending southerly therealong Lacasse Blvd. to the southerly limit of the intersection of Lacasse Blvd. and McNorton Street.

during the hours from 07:00 a.m. to 5:00 p.m., Monday to and including Friday, during the months of January through and including December yearly

That part of Lesperance Road beginning at the northerly limits of the intersection of Tecumseh Road and Lesperance Road and extending southerly therealong Lesperance Road to the southerly limit of the intersection of Lesperance Road and Renaud Street.

during the hours from 07:00 a.m. to 5:00 p.m., Monday to and including Friday, during the months of January through and including December yearly

That part of Dillon Drive beginning at the westerly limits of the intersection of Dillon Drive and Lesperance Road and extending easterly therealong Dillon Drive to the easterly limit of the intersection of Dillon Drive and Lacasse Boulevard.

during the hours from 07:00 a.m. to 5:00 p.m., Monday to and including Friday, during the months of January through and including December yearly

That part of St. Gregory's Drive beginning at the easterly limits of the intersection of Arlington Boulevard and St. Gregory's Road and extending westerly therealong St. Gregory's Drive to the westerly limit of the intersection of Manning Road and St. Gregory's Road.

during the hours from 07:00 a.m. to 5:00 p.m., Monday to and including Friday, during the months of January through and including December yearly

That part of County Road # 34 beginning at the easterly intersection of County Road #34 and Malden Road and extending easterly therealong County Road # 34 to 12256 County Road 34.

during the hours from 07:00 a.m. to 5:00 p.m., Monday to and including Friday, during the months of January through and including December yearly

That part of Tecumseh Road beginning at the westerly limits of the intersection of Tecumseh Road and Brighton Road and extending westerly therealong Tecumseh Road to the westerly limit of the intersection of Tecumseh Road and Arlington Boulevard.

during the hours from 07:00 a.m. to 5:00 p.m., Monday to and including Friday, during the months of January through and including December yearly

That part of North Talbot Road beginning at the southerly limits of the intersection of North Talbot Road and the Ninth Concession Road and extending westerly therealong North Talbot Road to the westerly limit of the intersection of North Talbot Road and the Eighth Concession Road.

during the hours from 07:00 a.m. to 5:00 p.m., Monday to and including Friday, during the months of January through and including December yearly

That part of Bellaire Street beginning at the easterly limits of the intersection of Bellaire Street and St. Alphonse Street and extending westerly therealong Bellaire Street to the westerly limit of the intersection of Bellaire Street and Lebeouf Street.

during the hours from 07:00 a.m. to 5:00 p.m., Monday to and including Friday, during the months of January through and including December yearly

That part of St. Thomas Street beginning at the easterly limits of the intersection of St. Thomas Street and Dillon Drive and extending westerly therealong St. Thomas Street to the westerly limit of the intersection of St. Thomas Street and Lacasse Blvd.

during the hours from 07:00 a.m. to 5:00 p.m., Monday to and including Friday, during the months of January through and including December yearly

That part of Arbour Street beginning at the westerly limits of the intersection of Arbour Street and Lesperance Road and extending westerly therealong Arbour Street to the St. Anne's High School lands.

during the hours from 07:00 a.m. to 5:00 p.m., Monday to and including Friday, during the months of January through and including December yearly

That part of Little River Boulevard beginning at the westerly limits of the intersection of Little River Boulevard and Manning Road and extending westerly therealong Little River Boulevard to the easterly limit of the intersection of Little River Boulevard and Donalda Crescent

during the hours from 07:00 a.m. to 10:00 p.m., Monday to and including Friday, during the months of January through and including December yearly

That part of Southfield Drive beginning at the northerly limits of the intersection of Southfield Drive and Hawk Lane and extending southerly therealong Southfield Drive to the southerly limit of the intersection of Southfield Drive and Champ Crescent

during the hours from 07:00 a.m. to 10:00 p.m., Monday to and including Friday, during the months of January through and including December yearly
