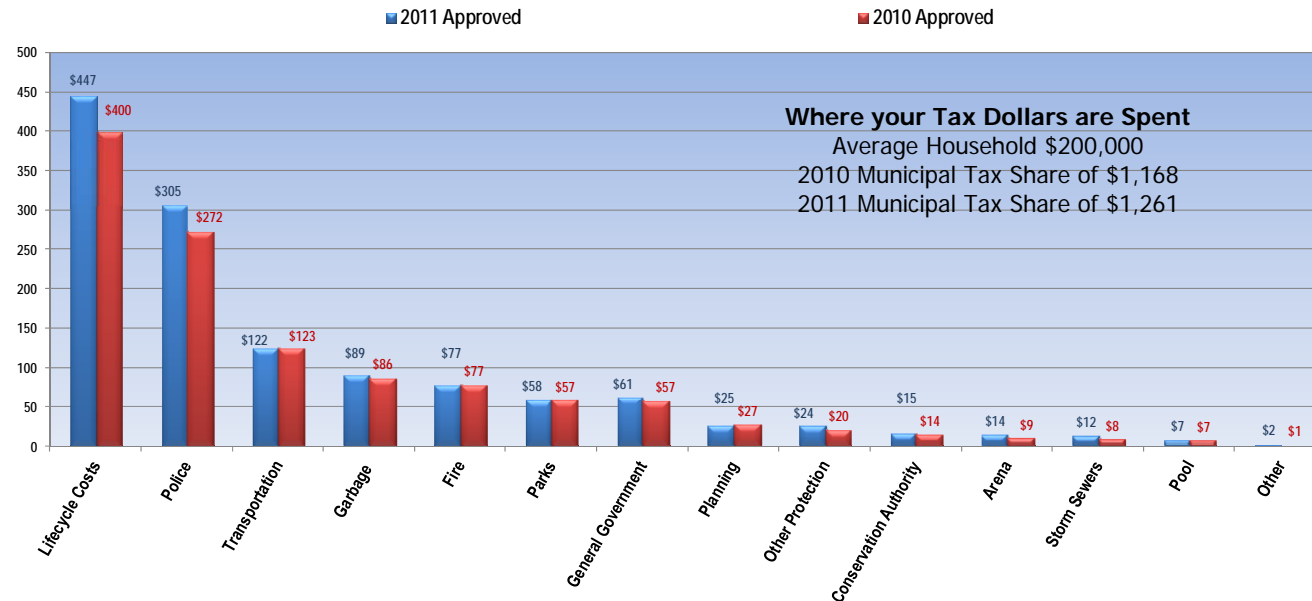

Tax Payments:

- **By Mail** - Cheques post-dated to the due date(s) are accepted. *DO NOT SEND CASH.* Please mail tax remittance stub and write your assessment roll number on the front of your cheque.
- **Telephone / PC Banking** - Payment may be made through any major Canadian Bank, via telephone or personal computer. Contact your own bank for details.
- **In Person** - Payment may be made in person, Monday to Friday, 8:30 am to 4:30 pm.
- **Pre-Authorized Payment (PAP) Plan** - Once enrolled in this plan, payments are automatically withdrawn from your bank.
- **Night Deposit Box** is located at the front door of the Municipal Town Hall, for your convenience.
